    - c. **FY 2016-17 Current Financial Statements** - The quarterly financial statements for the month ending September 30th included Statement of Revenues, Expenditures and Changes in Fund Balances.
    - d. **Review of draft of IRS Financial Form 990** – both Walton Academy and Walton Learning Center are included in the IRS draft. Ms. Roberts mentioned that the numbers all agree and expect no changes to the draft.Walton Learning Center
    - e. **FY 2016-17 Budget Amendment** – the budget was presented; the FTE did not change (based on beds at the facility).
